ORDER

In the Government Order read as first paper above, the Principals/ Superintendents of Medical College Hospitals, District Medical Officers (H), District Medical Officers (ISM), District Medical Officers (Homoeo) and the Principals / Superintendents of Ayurveda and Homoeo Medical Colleges were authorised to appoint qualified Doctors on adhoc / contract basis, as detailed in the annexure thereto. But the post of tutor and other paramedical staff in the Government Homoeo Medical Colleges Department were not incorporated in the annexure to the above Government Order. Subsequently as proposed by the Principal and Controlling Officer, Government in the Government Order read as second paper above, authorised the Principal and Controlling Officer, Government Homoeo Medical College, Thiruvananthapuram to fill up the post of Tutor and other Paramedical Staff in the two Government Homoeo Medical Colleges on adhoc / contract basis as detailed therein on payment of remuneration at the rates noted against each.

In the letter read above, the Principal, Government Homoeo Medical College, Kozhikode has reported that he had appointed six Tutors in Government Homoeo Medical College, Kozhikode on contract basis in exigencies of Service and requested to approve the appointment with retrospective effect and pay remuneration at the rate sanctioned in the Government Order second read above.

Government have examined the matter in detail and are pleased to ratify the action of the Principal, Government Homoeo Medical College, Kozhikode, in having appointed Tutors on contract basis in anticipation of Government Sanction. They will be paid remuneration at the same rate fixed as per the Government Order read as second paper.
