**PROSPECTUS FOR ADMISSION TO P.G. COURSES
IN HOMOEOPATHY – M.D. (HOM.),
Dr. ABHIN CHANDRA HOMOEOPATHIC MEDICAL COLLEGE
& HOSPITAL, BHUBANESWAR (ORISSA)**

1. GENERAL :

Dr. A. C. Homoeopathic Medical College & Hospital, Bhubaneswar is one of the best Homoeopathic Institutions of India. It is the premier Govt. Homoeopathic Medical college of the State, established in the year 1969. It is the first Homoeopathic College in the country to get the recognition of Dept. of Indian Systems of Medicine and Homoeopathy, (presently Dept. of AYUSH) Govt. of India as the **Model Homoeopathic College**.

It is the only institute among all the Homoeopathic Colleges of Orissa to get **accreditation** with the Dept. of Indian Systems of Medicine and Homoeopathy (presently Dept. of AYUSH), under Ministry of Health & Family Welfare, Govt. of India, for Research & Development in Homoeopathy.

Initially, the name of the college was "Govt. Homoeopathic Medical College & Hospital" which was later renamed as Dr. Abhin Chandra Homoeopathic Medical College and Hospital", in recognition of the services of late **Padmashree Dr. Abhin Ch. Rao**, the renowned Homoeopathic physician of Orissa who served as Honorary Homoeopathic Physician to three former Presidents of India.

The College imparted 4 & 1/2 years' Diploma course (D.H.M.S.) from the session 1969-70 which was substituted by 5 & 1/2 year's Degree course (B.H.M.S.) from the session 1977-78. Besides, the college was elevated to P.G. standard during the academic session 1996-97.

The college is affiliated to **Utkal University** and follows the syllabi and curricula prescribed by the university in the light of the recommendations of the Central Council of Homoeopathy, New Delhi, both for Under Graduate and Post Graduate courses.

P.G. Course in Homoeopathy-M.D.(Hom.) in the subject Materia Medica was introduced from the session 1996-97 vide G.O. No.9155/H., dt.29.03.95, in the subjects of Organon of Medicine and Repertory from the session 1997-98, vide G.O. No. 44267/H., dt.28.10.97 and in the subject of Practice of Medicine and Homoeopathic Pharmacy from the session 2007-08 vide G.O. No.15750/H., dt.14.06.2007.

2. AIM OF THE P.G. COURSE

- i) To provide adequate, meaningful teaching, training and research facilities in the field of Homoeopathy.
- ii) To produce young, skilled and efficient physicians, teachers and research scholars and specialists in respective fields.
- iii) To encourage research works in the field of Homoeopathy, with a view for establishing its scientificity.

3. SUBJECTS & SEATS

4. DURATION OF THE COURSE :

The duration of the P.G. Course shall be of 3 years including one year House Job in the Hospital attached to Dr. A. C. Homoeopathic Medical College, Bhubaneswar.

5. MANAGEMENT & CONTROL :

The internal administration and management relating to P.G. training in Dr. A. C. Homoeopathic Medical College & Hospital, Bhubaneswar shall be vested with the Head of the concerned department, under the general control of the Principal-cum-Superintendent of the college.

6. SESSION :

The academic session shall ordinarily commence from July, unless otherwise change of period is notified by the competent authority. Admission to the P.G Course will be made once in a year.

7. RESERVATION OF SEATS :

A) In the subject of Materia Medica, Repertory and Organon of Medicine & Homoeopathic Philosophy –

- i) **02 (two) seats in each discipline are open to all eligible candidates belonging to State of Orissa.**
- ii) **One seat in each discipline mentioned above are reserved for in-service candidates.**
- iii) **All seats mentioned in (i) and (ii) category are reserved for the permanent residents of Orissa only.**

Reservation for S.C. & S.T. for above two categories of students is separately mentioned as follows :

Reservation for candidates belonging to Clause 7. A (i) :

20% of seats shall be reserved for S.C. & S.T. candidates; of these 12% for S.T. & 8% for S.C. candidates.

In case of non-availability of eligible S.C. candidates, the seats shall be filled up by the eligible S.T. candidates and vice versa.

In case of non-availability of eligible S.C. or S.T. candidate(s), the same will be filled up by the eligible general candidate(s), subject to possessing the qualifying marks.

To achieve percentage of representation in P.G. admission for SC & ST candidates as well as General candidates a period of 5 years has been taken as one block to complete the percentage of representation. The block period started from 2008-09 and will continue upto 2012-13 which is shown in the table below.

Reservation : 20% of 30 = 06 seats. Anomaly of the last block period is adjusted.

Note : S.C./S.T. persons, who have migrated from other states to Orissa, for the purpose of education and employment etc. will not be treated as S.C. & S.T. candidates of the State as per order No. B.C.- 16014/1/84 - Scheduled Caste-B. C.D.I., dated the 22nd February'1985 of Govt. of India.

Reservation for In-Service candidates belonging to Clause 7. A (ii) :

In case of In-service doctors, 03 seats are earmarked for them, i.e. one each in the subject of Materia Medica, Repertory and Organon of Medicine and Homoeopathic Philosophy, provided the candidates secure qualifying marks in the entrance examination. In-service doctors who have completed atleast 5 years of continuous service being regularly recruited are only eligible for the above category and will get their salary from Govt. of Orissa as these seats are supernumerary seats and no stipend is earmarked for them. As these seats are supernumerary seats and no stipend is earmarked against these seats, these cannot be filled up by other than in-service candidates even if the seats are lying vacant for any case. To achieve the percentage of representation in P.G. Admission for S.C. & S.T. candidates as well as general candidates in in-service category, a period of five years has been taken as one block to complete the percentage of representation. 20% of seats shall be reserved for S.C. & S.T. candidates; of these 12% for S.T. & 8% for S.C. candidates. In case of non-availability of eligible S.C. candidates, the seats shall be filled up by the eligible S.T. candidates and vice versa. In case of non-availability of eligible S.C. or S.T. candidate(s), the same will be filled up by the eligible general candidate(s), subject to possessing the qualifying marks. The block period started from 2007-08 and will continue upto 2011-12 which is shown in the table below.

Reservation : 20% of 15 = 03 seats. Anomaly if any between SC & ST may be adjusted in the next block period].

7) **B) In the subjects of Practice of Medicine and Homoeopathic Pharmacy :**

i) As these two subjects are funded by Govt. of India, 50% of seats, in each department, shall be reserved for the candidates from outside the State of Orissa and 50% for candidates from inside Orissa, subject to the candidates secure the qualifying marks.

ii) In case, the seats reserved for the candidates of outside Orissa are not filled up, then these vacant seats shall be filled up by the candidates belonging to the State of Orissa and vice versa.

iii) 20% of seats shall be reserved for S.C. & S.T. candidates of these 12% for S.T. and 8% for S.C. candidate.

In case of non-availability of eligible S.C. candidates, the seats shall be filled up by the eligible S.T. candidates and vice versa.

In case of non-availability of eligible S.C. or S.T. candidate(s) the same will be filled up by the eligible general candidate(s), provided they possess the qualifying marks.

iv) To accord justice towards S.C. & S.T. reserved categories, as well as general categories, distribution of seats is done uniformly considering each category and taking five years as one block period (starting from 2007-08) which is shown in the following table.

N.B. : The distribution of seats for other States and Orissa may be reversed in the next block period, if total number of seats remain un-changed.

S.C. / S.T. persons, who have migrated from other states to Orissa, for the purpose of education and employment etc. will not be treated as S.C. & S.T. candidates as per order No.B.C. – 16014/1/84-Scheduled Caste – B.C.D.I., dated the 22nd February 1985 of Govt. of India.

8) STIPEND

a) The P.G. Students except In-service candidates, under State Government or Government of India shall get monthly stipend at the rate as will be decided by the Govt. of Orissa from time to time, subject to satisfactory performance of their duties and maintenance of academic discipline, during the whole period of study.

b) The stipend of the in-service P.G. students under employment of Govt. of Orissa, will be governed by the Resolution No. 3085/H dt.5.7.1976 and No. 38447/F dt.29.7.80 and such other orders of the Govt. of Orissa, as may be issued from time to time.

c) Every P.G. Student, on admission, shall execute a bond on stamp paper valued Rs.100/- in the form specified in **Annexure - 4** abiding to study and complete the course and in case he/she leaves the course or if his/her admission is cancelled by the authority, before completion of the course, for any reason, he/she shall return the amount of stipend received upto that date by him/her to the college.

d) The stipend is payable after verification of attendance and on recommendation of satisfactory progress by the Head of the department concerned.

9) ELIGIBILITY FOR ADMISSION TO P.G. COURSE :

(A) There are 02 (two) categories of candidates eligible for admission to M.D. (Hom.) course.

(i) In the subjects of Materia Medica, Repetory and Organon of Medicine and Homoeopathic Philosophy being funded by Govt. of Orissa, the candidates who are permanent resident of Orissa are eligible for admission.

(ii) In the subjects of Practice of Medicine and Homoeopathic Pharmacy being funded by Govt. of India, 50% seats are reserved for candidates outside the State of Orissa and rest 50% of seats are reserved for candidates belonging to the State of Orissa. Candidates seeking admission under the later category of Clause (ii) must be a permanent resident of Orissa.

(B) The candidates seeking admission for M.D. (Hom.) must possess :

i) A Degree qualification in Homoeopathy of not less than 5½ years duration (including 1 year compulsory rotatory internship) and included in the Second Schedule to Homoeopathy Central Council Act, 1973,

(or)

ii) A Graded Degree qualification in Homoeopathy obtained after undergoing a course of study in Homoeopathy of not less than 2 years duration, after passing Diploma course in Homoeopathy (of not less than 4 years duration), recognized by the C.C.H. and included in the Second Schedule to Homoeopathy Central Council Act, 1973.

10)PROCEDURE FOR SUBMISSION OF APPLICATION FORM :

- i) The candidate shall fill in the Application Form in his/her own handwriting neatly affixing a Passport size photograph at the appropriate space. He / she must put his / her **full signature** in the space provided.
- ii) Application Form complete in all respects along with the required documents should be sent by **Registered post/ Speed post/ Courier Service to Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College and Hospital, Unit-III, Bhubaneswar- 751001, on or before the last date for submission of Applications as indicated in the advertisement for the purpose.**
- iii) In-service candidates of Central/ State Government and students undergoing P.G. training in some other institution and seeking admission to P.G. courses, must produce 'No Objection Certificate', from their employers/ Heads of the institutions, as the case may be, in the format as in **Annexure – 3** at the time of counselling. It is the responsibility of the candidates to obtain and produce such Certificate, failing which they will **forfeit their claim for admission.**
- iv) The candidate shall fill in the **Admit Card in duplicate** attached to the application form and affix two pass port size photograph at the space meant for affixing the photograph.
- v) The candidate shall fill up the **Index card** attached to the application form clearly writing down his postal address at the appropriate space affixing postal stamp of **Rs.6.00.**
- vi) **Documents :** The following documents are to be attached to the Application form :-
 - a) Photocopy of the Board of Secondary Education Certificate or equivalent certificate.
 - b) Photocopy of Mark sheet of +2 Science or equivalent examination certificates.
 - c) Photocopy of B.H.M.S. or equivalent Degree certificate.
 - d) Photocopy of Mark sheet of Final B.H.M.S. or equivalent examination.
 - e) Photocopy of Internship Training completion Certificate.
 - f) Photocopy of Nativity Certificate (**Annexure – 1**).
 - g) Photocopy of Caste Certificate (**Annexure – 2**) in case of SC & ST candidate.
 - h) Photocopy of the licence for practice of Homoeopathic Medicine issued by State Board of Homoeopathic Medicine or by Central Council of Homoeopathy, alongwith updated renewal.

- i) Photocopy of “No objection certificate” (**Annexure-3**) from the employer / Head of the institution (in case of in-service candidates / students undergoing P.G. training in some other institution).
- j) Original Money receipt in support of payment towards cost of Prospectus, Application form and Examination Fees.
- k) Three recent identical passport size (B/W) photographs attested clearly on the front side, (one pasted at the appropriate place on the first page of the Application form and two tagged with the Application form).
- l) Two self addressed envelopes (23 Cm. X 10 Cm. Size).
- m) Affix postage stamp on the **Envelop for sending Admit Card** as applicable for **Regd. Post**.
- n) Papers in support of rendering service in tribal and backward area of the State for more than 03 years.

N.B. : All the photocopies of the documents enclosed by the candidate must be signed by him / her mentioning the words “submitted by me.”

SCRUTINY :

- i. Principal of the college shall not be held responsible for postal delay / loss in respect of receipt of Application form or delivery of Admit Card for appearing at the Entrance Examination.
- ii. Incomplete application forms in any respect shall be liable for rejection and no correspondence in this regard would be entertained.

11)SELECTION OF CANDIDATES FOR ADMISSION :

Selection Committee :

- a) Selection of candidates for admission to P.G. Course shall be made by the Selection Committee, constituted by the Government of Orissa with the following members :-
 - 1) Director of Indian Medicines & Homoeopathy, Orissa - Chairman
 - 2) Principal-cum-Superintendent,
Dr. A. C. Homoeopathic Medical
College and Hospital, Bhubaneswar. - Member and
Convenor
 - 3) Heads of concerned subjects - Members.
(Materia Medica / Organon of Medicine /
Repertory / Practice of Medicine and Homoeopathic
Pharmacy)

b) Basis of Selection

- i) The selection of candidates for M.D.(Hom.) Course will be made **on the basis of merit in the Entrance Examination** (written test). The examination shall be conducted in English medium only.
- ii) **Qualifying marks** for admission will be 50% of the total marks in Entrance Examination in case of general candidates & 40% of the total marks in case of S.C./S.T. candidates. The candidates without securing the qualifying marks shall not be selected even if the seats fall vacant.
- iii) There shall be **one paper of 1½ hours duration** containing 100 **multiple choice questions**. Each question will carry 2 marks and as such the **total marks shall be 200**.
- iv) The subject wise distribution of question in the entrance examination is as follows.

Evaluation :

- v) All questions will be of objective type, of the standard of B.H.M.S. Examination and mostly cover all the subjects of the B.H.M.S. Course. The marks will be awarded as follows :

- vi) In case of equal mark at the Entrance Examination), the inter-se merit of the candidates shall be determined on the basis of the marks obtained by the candidates in the Final B.H.M.S./ Graded B.H.M.S. Examination in first attempt.

In case of further tie, the decision of the P.G. Selection Committee shall be final.

- vii) The subjects will be allocated to the candidates on the basis of their merit in the Entrance Examination, during counselling.
- viii) Scrutiny or re-valuation of the papers of Entrance Examination shall not be allowed on any ground. In any controversy, the decision taken by the Selection Committee shall be final and binding.
- ix) The benefit of additional weightage of marks to the extent of 5% in the qualifying examination will be extended to in-service candidates only who have rendered minimum 03 years of service in the tribal / backward areas notified by Government. (Letter No.22839/H., dt.01.07.1998 of H. & F.W. Deptt.)

12. PROCEDURE OF ADMISSION :

- I) After notification of the select list, the selected candidates will be intimated by the Principal-cum-Superintendent to appear for counselling to take admission on a specific date. After allotting the subjects to the candidates, they will be admitted on depositing prescribed fees and verification of original documents on the same day.
- II) If a selected candidate, after counselling, fails to take admission, on the same day, he/she will forfeit his/ her claim for admission and the next candidate from the waiting list shall be admitted in his/her place.

13. CHANGE OF SUBJECT :

Once a subject is allotted to a candidate after counselling, he/she will not be permitted to change over to another subject.

14. VACANCY :

In the event of any vacancy of seat arising within **two months** of first admission, the same may be filled up from the waiting list, within 15 days of notification of such vacancy. In such case, the candidates already admitted in other departments will be given scope to re-exercise options and final allotment of subjects will be done by the Selection Committee, on the basis of the rank secured by the candidates in the entrance test.

15. COURSES OF STUDIES :

The courses of studies, syllabi, methods of examination, registration of candidates, selection of guides and examiners for Post Graduate studies shall be regulated by the provisions of the Utkal University.

16. EXAMINATIONS :

- i) The examination shall be conducted in two parts :

M.D.(Hom.) Part-I Examination, after one & half years of taking admission and **M.D.(Hom.) Part-II Examination**, after three years of taking admission and passing Part-I Examination.

- ii) The candidate shall prepare and submit his/her thesis to the guide at least nine months prior to the holding of Part-II Examination. His/her appearance in the Part-II Examination is subject to the approval of his / her thesis by the Utkal University.

17. ATTENDANCE :

- i) Every student is required to attend their classes and duties punctually at the stated hours assigned to them, by the authorities.
- ii) Every student must obtain at least 75 percent of attendance in theoretical/ practical/ clinical classes etc, to entitle him/her to appear at the examinations.

18. LEAVE :

- i) P.G. Students will be allowed 15 days casual leave in an academic year but not exceeding 10 days at a stretch.
- ii) 15 days leave is permissible in an academic year, on medical ground, on submission of medical certificate issued by a registered qualified medical practitioner, subject to the satisfaction of the authority.
- iii) No stipend shall be paid if a student remains absent for period more than the period mentioned under Para (i) & (ii) above.

N.B. :-

- i) The fees are subject to modification, from time to time, as decided by the Govt. of Orissa.
- ii) Particulars of University fees and fees for examination, Centre charges, late fee, fee for mark-sheet etc. shall be notified to the candidates by the Principal.
- iii) Refundable fees such as caution money shall be collected in one installment at the time of admission.
- iv) **Tuition fees** shall be collected half yearly (every 6 months), i.e. on 5th of July and **5th of January of each** academic year without fine and on the last working day of the concerned month with a fine of Rs.15/- per month.
- v) Hostel dues collected on 15th July of every year without fine and thereafter with a fine of Rs.15.00 for the delay of one month or part thereof.
- vi) Other annual dues shall be collected on **5th of July** of each academic year.

20. HOSTEL ACCOMMODATION :

- i) Hostel accommodation (for boys and girls) will be provided strictly on the availability of seats in the hostels.
- ii) Hostel accommodation, being limited, can't be provided to all. Allotment of seats in hostels shall be made by the Superintendent in consultation with the Principal to the needy and deserving students.
- iii) Students who are not allotted hostel seats shall have to arrange their own accommodation.
- iv) Hostel caution money shall be deposited at the time of allotment of seat in the hostel.
- v) The boarders of the hostel shall have to strictly abide by the hostel rules and pay their fees/dues including electricity & water charges regularly. Violation of hostel rules or non-payment of the prescribed fees/dues regularly shall make the boarders liable for expulsion from hostel.
- vi) Principal-cum-Superintendent, Dr. A. C. Homoeopathic Medical College and Hospital, Bhubaneswar will be the final authority to grant and refuse admission in hostel. No appeal will be entertained against his decision.

21. MISCELLANEOUS :

- i) P.G. students after admission should maintain strict discipline and devote entire period in study and research activities. Any student whose behavior is found to be detrimental to the interest of the institution will be penalized, even to the extent of expulsion.
- ii) P.G. Students will not be allowed to do any type of job or private practice, outside the institution, during period of their P.G. Training.
- iii) A student will be liable for expulsion for offences involving disgraceful or dishonourable conduct, for persistent or willful violation of college/hospital/hostel rules, for in-subordination and breach of discipline, or adopting unfair means in the examination or **being involved in ragging** or such other act which jeopardises the interest and dignity of the institution.
- iv) Students are forbidden to approach the higher authorities in any matter pertaining to the institution without obtaining permission of the concerned H.O.D. and the Principal.
- v) Matters not covered by these rules will be decided by the Principal-cum-Superintendent of Dr. A. C. Homoeopathic Medical College & Hospital, Bhubaneswar whose decision shall be final.
