Subject: Implementation of provisions of Homoeopathy (Minimum Standard of Education) Regulations, 1983- reg.

Sir,

The Central Council of Homoeopathy vide Gazette Notification dated 11th May, 1983 has notified the Homoeopathy (Minimum Standards of Education) Regulations 1983 which provides certain measurable norms and conditions as summarized and given at **Annexure-I**. The Regulation 6 provides that the admission of students to Homoeopathy colleges for degree course shall be allowed to the colleges which are fulfilling the minimum requirements as set out in the Regulations, 1983.

- 2. On perusal of the inspection reports of the inspections as carried out by the CCH inspectors/ visitors of some of the existing/ newly established Homoeopathy Medical Colleges, it has been found that many medical colleges are not fulfilling the minimum standards, norms of CCH with regard to availability of infrastructure, teaching and non-teaching staff. Similarly, Central Government has also received complaints in this regard. This scenario gives apprehension that there may be possibility of growth of substandard education. Similarly, the existence of such substandard colleges may create a possibility of adopting malpractices and unfair practices by the colleges.
- 3. The situation as brought out in 'Para-2' above appear to be occurring primarily because of the scanty inspections being carried out by the CCH. However, the HCC Act,1973 has been amended in the year 2002 vide The HCC(Amendment)Act, 2002 with the objective to control mushroom growth of colleges and prevents a fall in the

standards of education. In this background to ensure the quality of Homoeopathy medical education and safeguarding the interest of students, it is necessary to adopt urgent measures to regularly monitor the Homoeopathy Medical Colleges.

- 4. The HCC (inspector and visitors) Regulation, 1982 vide Rule no. 6(2) and Rule no. 10(2) provides for inclusion of information in the inspection/visitation report about teaching facility, equipments, accommodation and staff existing at such college, hospital institutions and other sections attached to them in course of the inspection/visitation to be carried out by CCH inspectors and visitors for inspection of Homoeopathy Medical Colleges for ascertaining the sufficiency of every examination being conducted at these medical colleges as per the provision of Section 17 & 18 of HCC Act 1973. Similarly, Section 17(2) and Section 18(3) also provides for inspection/visitation by CCH inspectors/visitors to ascertain the adequacy of the standards of education including staff, equipment, accommodation, training and other facilities prescribed for giving education in Homeopathy or on the sufficiency of every examination. Further the Rule No. 3(2) of HCC (inspector and visitors) Regulation, 1982 has assigned the duty to the Registrar-cum-Secretary, CCH "to ascertain periodically from the University, Board or any other Medical Institution conducting examination in Homoeopathy, the date and place of every such examination which may be inspected by Central Council".
- 5. In each Homoeopathy Medical College every year minimum four examinations, i.e., 1st, 2nd, 3rd and 4th BHMS Professional Courses are being conducted. In view of the objective of the HCC(Amendment) Act,2002 to ensure imparting of quality education, to inspect the Homoeopathy Medical College at least once in a year appears to be essential. Therefore, in order to preserve the conformity and spirit of the HCC Act, 1973 specifically read with the provisions of section 17 & 18 and with the provision of Regulation 6(2) and 10(2) of HCC (Inspector and Visitation) Regulations, 1982, Central Government desires that with immediate effect CCH may carry out the following:-
- (i) To carry out the inspection/ visitation of all Homoeopathy Medical Colleges minimum once in a year during January to March of each calendar year to ascertain the availability of teachers, equipment, accommodation, training and other facilities as specified in Homoeopathy (MSE) Regulations, 1983 and submit their report and

recommendation to the Central Government by the end of April every calendar year. At first instance, the Council should carry out inspection of those 11(eleven) colleges which have been granted permission by the Department under provision of Section 12(A) of HCC Act, 2002, from 2004-05 onwards (list enclosed at Annexure-2) and the 72 colleges which were granted permission by the Department's order No R.11011/03/2003-EP (Pt.) dated 13th September, 2004 (list enclosed at Annexure-3). Subsequently, the other remaining colleges may also be covered by such inspections/visitations to be carried out by CCH inspectors/visitors upto December, 2011.

- (ii) A proforma is enclosed(Annexure-4) for submitting the reports of inspection/visitation. Apart from this proforma, any other facts or information with regard to the functioning of college and hospital may be made available, for this purpose by the visitors/ inspectors of CCH as regarding the availability of infrastructure, hospital functioning at the Homoeopathy Medical College being inspected by them.
- (iii) In order to accomplish the inspections of 83 Homoeopathy Medical Colleges within a short time, mentioned in 'Para-1', the Council is requested to utilize the services of teachers from different State Government Homoeopathy Colleges also to undertake the visit of 83 Homoeopathy Medical colleges by 30.4.2011. A copy of CCH's letter to be written to the concerned State Homoeopathy Medical College/ Government Teacher/ Secretary of the State may be urgently sent to the Department, so that the department can also take up with the State Governments.
- (iv) The visitation/ inspection reports along with CCH's recommendations pertaining to the above said 83 colleges on the availability of having requirements as specified in provisions of Homoeopathy (MSE) Regulations, 1983, should be made available to the Central Government by 31.05.2011, so that Central Government may take further appropriate action in view of the provisions of the HCC Act, 1973, HCC(Amendment)Act, 2002 and Regulations made there under.

(v) Apart from above procedure for allowing admissions in existing colleges, the CCH is also requested to strictly monitor the compliance of Homoeopathy (Minimum Standard of Education) Regulations, 1983 before sending any recommendations to the Central Government in respect of either inclusion of degrees in second schedule of HCC Act, 1973 or proposals as received under Section 12A of HCC Act, 1973.

This issues with the approval of competent authority.

Annexure-1

Measurable Minimum requirements –

The Regulation no:3 of these Regulations provide for "Minimum requirements: There shall be attached to every Homoeopathic College a Hospital having not less than 25 beds and having minimum requirements, norms and standards as specified by these regulations in regard to teaching as well as hospital staff, equipment, accommodation, training and other facilities and such Homoeopathic Colleges shall also have one peripheral Homoeopathic clinic for every 10 admissions". The summary of measurable norms are as follows:-

- (i) Hospital Minimum 25 bedded hospital with one peripheral homeopathy clinic for every 10 admission along with the student bed ratio 1:1
- (ii) Minimum teaching staff for BHMS degree college 13 Professors, 15 Reader and 15 lecturers totaling 43. Out of which 37 should be full time and 6 can be part-time.
- (iii) Non-teaching staff 8 employees.
- (iv) Hospital Staff for 50 bedded hospital 41 full time and 9 part-time.
- (v) Equipments 466 equipments as listed in Annexure-F.
- (vi) Lecture Hall 6
- (vii) Teaching Lab Lab in three specified departments
- (viii) OPD Running OPD in 8 departments.
- (ix) IPD Running IPD with 4 wards
- (x) Museum Museum in 5 specified departments.
