Rules and Regulations of Training Programme

- 1.Application Fee is Rs.50/-. Those who download the application form, shall attach DD of Rs. 50/- in favour of Managing Director, HOMCO payable at Alappuzha.
- 2. Duration of Training is Eighteen months.
- 3.The candidate should submit original receipt of the application fee paid or DD and copies of the certificates to prove their age and educational qualifications including registration certificates and Transfer Certificate along with the application form.
- 4. Eligibility for admission: Homoeopathic Doctors having B.H.M.S/D.H.M.S or equivalent
- 5.Age: Maximum age 40 years as on 01.10.2009.
- 6.Training: The training shall be provided for 6 persons at a time. The candidate should attend duty for 8 hrs a day including night shifts.
- 7. Mode of selection: Selection of candidates shall be on the basis of an interview.
- 8.Course Fee: The selected candidates shall pay a caution deposit of Rs.5000/- (Rupees Five Thousand only) at the time of admission, which shall be returned without interest at the end of the training. A fee @ of Rs.300/- (Rupees three hundred only) per month shall be fixed for training amounting to Rs.5400/- (Rupees five thousand four hundred only) for eighteen months which shall be paid by the candidate in three installments.
- 9.Training Certificate: There shall be two assessment tests at the end of each six months and a final assessment test at the end of the training. A minimum of 80% attendance and a pass in one of the previous assessment tests is compulsory for attending the final assessment test. Those who had successfully completed the training and passed the final assessment test shall be issued a Training Certificate in Manufacture of Homoeopathic Medicines. Those who had failed the final test shall be given three chances to appear the test.
- 10.Leaves shall be allowed as per Pharmacy Rules.
- 11.Employment in the Pharmacy: The training shall not be a claim for any employment in the Pharmacy.
- 12. The duly filled up application may be sent to the Managing Director so as to reach the office **before 5 p.m on 31.10.09.** Application forms without the original receipt of the application fee / DD will be primarily rejected.
- 13.Stipend: The trainees on completion of six months training shall be eligible for stipend of Rs. 4000/- per month for the remaining 12 months.
