ORDER

As per the representation read as 1st paper, Dr. Smitha Madhavan, Tutor, Government Homoeopathic Medical College, Kozhikode has requested Government to grant deputation to her to the Government Homoeopathic Medical College, Kozhikode as that she is doing her PG Course (MD-Homoeo) there.

As per the letter read as 3rd paper, the Principal & Controlling Officer, Government Homoeopathic Medical College, Thiruvananthapuram has reported that Dr. Smitha Madhavan, Tutor, Department of Organon of Medicine, Government Homoeopathic Medical College, Kozhikode is doing her PG Degree (MD-Homoeo) in the above College and she could not join her promoted post since Government had promoted her as Lecturer and transferred to Government Homoeopathic Medical College, Thiruvananthapuram as per the Government Order read as 2nd paper. In order to continue her study in the Government Homoeopathic Medical College, Kozhikode, the Principal & Controlling Officer has requested Government to shift one post of Lecturer in the Department of Organon of Medicine, Government Homoeopathic Medical College, Thiruvananthapuram to Government Homoeopathic Medical College, Kozhikode and one post of Tutor in the Department of Organon of Medicine, Government Homoeopathic Medical College, Kozhikode to Government Homoeopathic Medical College, Thiruvananthapuram, so as to accommodate the incumbent in the Government Homoeopathic Medical College, Kozhikode and to continue her study.

Government have examined the matter in detail and are pleased to shift one post of Tutor in the Organon of Medicine, Government Homoeopathic Medical College, Kozhikode and one post of Lecturer in the Department of Organon of Medicine, Government Homoeopathic Medical College, Thiruvananthapuram mutually and Dr. Smitha Madhavan stands promoted as Lecturer is posted to the Government Homoeopathic Medical College, Kozhikode in the shifted post, subject to the following conditions:-

- i) The shifting of posts as above is till the date of completion of her course and then the above posts are automatically shifted back to the parent Institution.
- ii) The incumbent will join in the Government Homoeopathic Medical College, Thiruvananthapuram immediately on completion of her Course and against the post shifted back as above.
- iii) Her promotion as Lecturer will effective only from th date of joining as Lecturer.


