## ORDER

In the Annual Plan for 2010-11, an amount of ₹ 100 lakh under the head of account 2210-02-102-82 (Plan) has been provided for starting new dispensaries in general sector. At present there are 526 Govt. Homoeo Dispensaries in which, 461 Dispensaries in general sector, 42 under special component plan and 23 under Tribal Sub Plan. As per the letters read above, the Director of Homoeopathy has forwarded proposal for opening 25 Homoeo Dispensaries in general sector along with list of 246 Grama Panchayats which expresses their willingness to provide infrastructure facilities for starting new Homoeo Dispensaries. The Director of Homoeopathy has reported that 4 posts per Dispensary are required for starting new Dispensaries. The financial commitment for opening a single dispensary for the remaining 3 months will be ₹ 1.2 lakh and thus the total financial commitment for opening 25 dispensaries will be ₹ 30 lakh during the current year.

2. Government have examined the matter in detail and are pleased to accord sanction for opening Homoeo Dispensaries in the general sector in the following 25 Grama Panchayats where infrastructure are available.
