ORDER

As per the G.O read as 1st paper, Government have decided to introduce Direct Payment System in the 3 Private Homoeopathic Medical Colleges and one of the college is Shree Vidyadhiraja Homoeopathic Medical College, Nemom, Thiruvananthapuram. But Direct Payment System was introduced in Shree Vidyadhiraja Homoeopathic Medical College, Nemon, Thiruvananthapuram as per the G.O read as 2nd paper but the fixation of staff and approval of the staff against the staff strength for the said college was not finalised at that time. Subsequently as per the G.O read as 3rd paper the staff strength of the Shree Vidyadhiraja Homoeopathic Medical College, Nemom has been fixed. As per which 31 posts of teaching staff and 25 posts of non-teaching staff were sanctioned. Approval was also given to the persons against those posts. . In addition to the above posts 11 numbers of teaching staff in the college as per the list given as Table -2 in the Annexure of the above GO read as 3rd paper were treated as excess staff who will be ordered to be absorbed against the post of Tutor as and when vacancies arise in future. They were ordered to be considered for regular appointment under Direct Payment System in the order of their seniority. The 1st person in the excess teaching staff, Dr. Nayana. C.J has already been regularised under Direct Payment System.

2. Consequent on issuance of the GO read as 3rd paper, a number of employees have filed objection/appeal before Government. After considering those petitions/appeals in detail, orders have been issued as per the GO read as 4th paper. As per the Order 31 posts of teaching staff including Principal and 27 posts of non-teaching staff have been sanctioned and employees have been approved against those posts except for the post of Principal.

3. Government have reviewed the matter. The posts sanctioned are not sufficient for the smooth functioning of the college. To achieve the staff pattern to the Central Council of Homoeopathy norms to the possible extent, Government are pleased to order the following: -
