The candidates who have secured 87 marks and above in the Objective Type (OMR) Test are included in the Main List of this Short List.

The candidates belonging to Backward classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O(P)No.36/2000 /SC/ST/DD dated 27.5.2000 shall produce the same at the time of interview. Those in the Main list who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of community and will be considered as Open Competition candidates. The Register Numbers of candidates who are liable to produce Non-Creamy Layer Certificates and included in the Supplementary Lists of Backward Classes and who fail to produce the Non-Creamy Layer Certificates shall be deleted from the Short List without further notice.

The date, time and place of interview will be intimated later.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked if the prescribed fee of Rs.10/-(Rupees Ten Only) per paper is remitted in any one of the Treasuries in the State by chalan under the head of account "**0051 PSC-105 State PSC-99 Examination Fee**". A period of one month's time each for rechecking will be allowed to candidates with effect from the date of publication of Short list and Ranked list. Candidates whose Register Numbers not included in the Short List may submit application for rechecking within one month from the date of the publication of the Short List. They will not be given a chance for rechecking after the publication of the Ranked List. The candidates can avail only one chance either after the publication of Short list or after the publication of Ranked list. The application for rechecking together with the original chalan receipt for the prescribed fee addressed to the **Deputy Secretary (Examinations) I, Office of the Kerala Public Service Commission, Pattom Palace.P.O, Thiruvananthapuram-695004** should reach this office within 30 days from the day on which this notification is officially released by the Public Service Commission.
