Those in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of communal reservation and will be considered as Open Competition candidates. The Register Numbers of candidates, who are liable to produce non Creamy Layer Certificates and included in the Supplementary Lists of Backward Classes and who fail to produce the Non Creamy Layer Certificates shall be deleted from the Short List without further notice. The date, time and place of interview will be intimated in due course.
