## **ORDER**

As per Government Order read as 1st paper, Government decided to introduce Direct Payment System in the 3 Private Homoeopathic Medical colleges in the State subject to terms and conditions. Direct Payment System was introduced in Shree Vidvadhiraia Homoeopathic Medical College, Nemom, Thiruvananthapuram with effect from 01/09/02 as per the Government Order read as 2<sup>nd</sup> paper. Later a staff pattern consisting of 31 teaching and 25 non-teaching staff for the College was approved by Government vide Government Order read as 3rd paper. pattern of Shree Vidvadhiraia Homoeopathic Medical College, Thiruvananthapuram was fixed provisionally vide Government Order read as 4th paper. Pursuant to the issuance of the Government Order read as 4th paper above, a number of employees filed objection/appeal before Government. After considering these petitions/appeal in detail Government issued revised orders with modifications as per Government Order read as 5th paper. As a part of Government decision to implement Central Council of Homoeopathy (CCH) teaching staff pattern in the Aided Homoeoopathic Medical Colleges in the State, Government created Professor - 2, Reader - 3 and Lecturer - 6 subject to condition that the Lecturer posts are treated as created in the Departments were the senior most 6 persons are presently working and to regularise the 10 remaining excess teaching staff in the first ten resultant vacancies in the cadre of Tutor.

2. As Government could only accommodate 31 teaching and 25 non teaching staff, those who became excess in several categories approached Government for getting their appointment approved along with others who got accommodation in the Direct Payment System. Many of them approached Hon'ble High Court by filing various Writ Petitions. Government seized the matter and a

meeting under the Chairmanship of the Chief Minister was convened on 31/08/11 with the representatives of staff and Management of the college to find a solution for the impasse. In the meeting it had been decided to allow teaching posts in the college in tune with Central Council of Homoeopathy pattern. It has also been decided to consider the creation of more non teaching staff in the college, if found necessary subject to the condition that total number of posts will not exceed 48, and to include the staff required in the Hospital section also. In addition to the above it had also been tentatively decided to create 4 posts of Medical Officers in the hospital attached to the college. The decision taken in the Chief Minister's meeting on 31/08/11 was further examined in consultation with the Principal & Controlling Officer and it was decided to implement teaching pattern prescribed by the Central Council of Homoeopathy in Shree Vidyadhiraja Homoeopathic Medical College, Nemom, Thiruvananthapuram.

- 3. Government examined the matter in detail. The existing teaching pattern in the College as per Government Order read as 4th and 6th paper is Tutor 28, Lecturer 9, Reader 3 and Professor –2. To attain the Central Council of Homoeopathy pattern of Professor 13, Reader 15 and Lecturer 15, Government hereby create posts of Professor-11, Reader-12 and Lecturer-6 in Shree Vidyadhiraja Homoeopathic Medical College, Nemom, Thiruvananthapuram with prospective effect. The existing qualified teachers will be absorbed in the teaching post of Professor, Reader and Lecturer as per the existing Special Rules and if they are not qualified they will be allowed to continue in the existing cadre and will be promoted to higher posts as and when they become eligible for the post, limiting the total teaching post in the college at 43.
- 4. The existing Tutor posts will be treated as vanished after absorbing the undermentioned 10 excess teaching staff vide Government Order read as 4<sup>th</sup> paper and on their subsequent promotion to higher posts to Lecturer, Reader and Professor, subject to the condition that the departments which have already been specified for the teachers shall not be changed.

- 5. The Principal & Controlling Officer will take up the proposal with the Registrar, University of Kerala regarding approval of the appointment of teaching staff.
- 6. Government also hereby accord sanction to create 4 posts of Homoeo Doctors (Resident Medical Officer) in the scale of ₹ 20740-36140 in the College.
- 7. The Management of Shree Vidyadhiraja Homoeopathic Medical College, Nemom, Thiruvananthapuram will provide infrastructure facilities like land, building, classrooms, Library, computer room, equipment, playground, hospitals and periferal facilities within 3 months as per the Central Council of Homoeopathy norms. The Principal & Controlling Officer/ Government will conduct periodical inspection in the institution.
  - 8. The orders on creation of non teaching posts will be issued separately.
