ORDER

Government are pleased to accord sanction to start 14 temporary Homoeo Dispensaries in Panchayats/Local Self Government Institutions mentioned in the list appended to this order subject to the following conditions:-

- 1) The service of Homoeo Doctors will be provided by the Homoeopathy Department, on temporary/contract basis initially for 6 months, using funds provided by the National Rural Health Mission. The period will be extended further after review of the performance and requirements.
- 2) Dispensaries will start functioning where infrastructure facilities are made available by the Panchayats/Municipalities. Wherever separate buildings are not available, dispensaries may be started, if adequate space for consulting room, stores, toilet etc, is provided in existing/rented building.
- 3) Medicines will be provided for the time being by the concerned District Medical Officers using funds to be provided by the National Rural Health Mission. The Panchayats/Municipalities will also arrange to provide medicines, if possible, from their own funds after getting necessary approvals from the competent authorities.
- 4) The Doctor posted in the dispensary will be responsible for all the duties connected with the treatment of patients, including maintenance of registers, accounts, dispensing medicines as provided etc.
